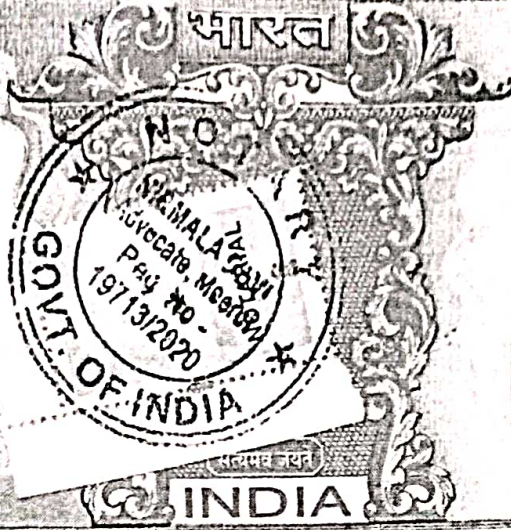

➤ Meeting was chaired by Mr. Brajesh Raj

➤ A meeting of above-mentioned members was called on Date- 6/03/24 in the cabin of Mr Brajesh Raj regarding a written complaint that was given by “ Nitin Verma” , student of BBA 1<sup>st</sup> Year against “Garvit Mishra” , student of IIMT College of Polytechnic , 2nd Year electrical department.

➤ Discussion was held regarding the complaint received and following points were noted-

(a) Garvit had gone to a Mussoorie trip in December along with some of his friends. During that trip he contacted a student on phone that comes to college along with him in college bus to college to give him some money to drink water in a casual way.

(b) Thereafter since Garvit has returned from that trip some students of the college bus (Nitin Verma BBA 1<sup>st</sup> Year and Prason Dubey B.Pharma 1<sup>st</sup> year) were poking him using the word “paani” again and again to make Garvit feel that he don't even have the money to purchase water.

(c) Also, it was noticed that during this period since Garvit returned from trip there were many occasions when both Garvit and Nitin used to abuse each other in bus on frequent basis.

(d) On 1<sup>st</sup> march again both the students were involved in confrontation with each other , during which Garvit punched Nitin with his fist near his eyes due to which Nitin started bleeding. Also, Garvit threw the shoes of Nitin outside from the bus window after that.

(e) Nitin had to be taken to hospital later that evening to get stiches done on his eyebrows near his eyes.

➤ It was observed that the complaint received was genuine and following actions were taken—

(a) Student “Garvit Mishra” has been suspended from the college bus services as well as from the college till 22<sup>nd</sup> march 2024.

(b) His father will have to submit an undertaking that his son will not repeat such actions in future.

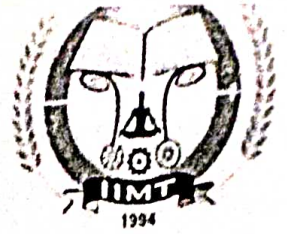

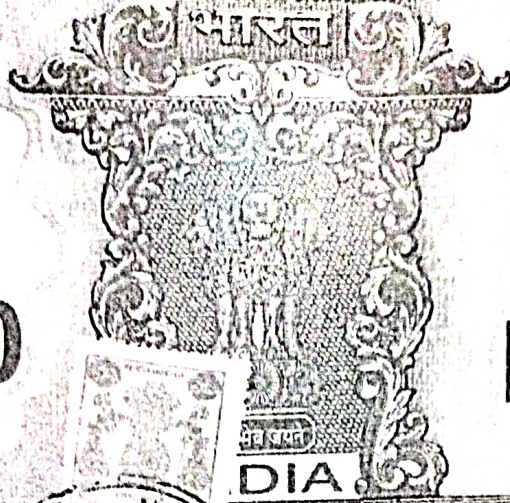

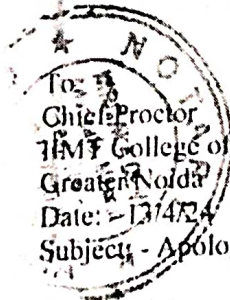
