Minutes of first Meeting held on dt. 07-09-2023




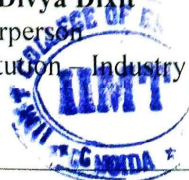
Agenda:
